D&B

Note: It is preferred that all Symantec suppliers be registered with Dun and Bradstreet (D&B). If you currently are not registered with D&B, go to the D&B website and register to receive your 9-digit registration number. This number should then be included on your iSupplier registration.

If a D&B number is not provided in the iSupplier registration, you are required to provide additional documentation in the form of one of the following documents. Make sure that the company name and address stated on the iSupplier registration match those on the supporting documentation provided:

- Business license
- Legal registration form (from the country's government company registration authorities)
- Registration form from the Chamber of Commerce
- Certificate of Incorporation
- Official tax document
- Active contract between supplier and Symantec
- Financial statement (Japan only)
- Black Economic Empowerment (BEE) Certification (South Africa Only)
- Approval letter from an accounting firm of BEE Certification (South Africa only)
- Sample invoice

To expedite your request, Symantec advises you to complete your iSupplier registration in English.

Purpose

The iSupplier registration is intended for new suppliers who have been invited by Symantec to become a Symantec supplier. The information provided as part of the iSupplier registration will be entered into the Symantec supplier database.

No PO/No Pay Policy

No work should be performed until a PO is issued. Invoices must reference a corresponding PO number and invoices without a valid PO number will be returned unpaid.

Requirements

- Symantec will **not** accept unsolicited iSupplier registrations.
- Symantec will not accept incomplete iSupplier registrations. All required pages/fields must be completed.
- Symantec requires that the Tax ID field be completed when applicable. Use this field to enter your Tax ID, VAT, ABN, GST, PAN, etc depending on your country specifications.

Payments

We pay suppliers electronically. Make sure that you provide correct banking details when you enroll.

Additional Country Specific Requirements

Please note that some countries have additional requirements upon registration. Please see below for any country specific requirements.

UNITED STATES (Suppliers Doing Business with Symantec)

Symantec Corporation is required to obtain and maintain complete, up-to-date, and accurate tax documentation from its suppliers to comply with U.S. tax withholding and reporting obligations, as directed by the U.S. Internal Revenue Service ("IRS").

Each organization in any location that serves as a supplier to Symantec must provide Symantec with the appropriate U.S. tax documentation. You must provide Symantec with an appropriate IRS form (Form W-8BEN or W-9) based on your residency and entity classification for U.S. tax purposes. Your enrollment package will not be processed until you have provided the complete and correct tax documentation.

If you are a non-U.S. resident supplier, complete the following forms: W-8BEN
