The Symantec Identity Security Portfolio License Agreement (PLA) gives you access to more solutions across the Symantec Identity Security portfolio without new contracts. It is a highly competitive package for identity protection and provides a one-stop shop for identity security at a lower total cost of ownership (TCO) with improved administration. It's a low risk way to quickly add users, products, and try new capabilities.

What the Identity PLA Does for You?

When you sign an Identity Security PLA, you are able to extend your identity security at your own pace. Here are examples of how that works:



Add Privileged Account Protection: You have Symantec SiteMinder to protect and manage access to your customer and employee applications. With an Identity Security PLA, just add Symantec Privileged Access Management (PAM) to protect sensitive administrative credentials, control privileged user access, proactively enforce security policies, and monitor and record privileged user activity across virtual, cloud, and physical environments.



Automate Risk Mitigation: You have Symantec Privileged Access Manager but your team can't keep up with the alerts and manage all the potential threats. Add Threat Analytics to monitor all privileged user activity, analyze it in real-time, and trigger automatic mitigation actions when unusual behavior is detected. The solution enables an immediate response to potential risks without any human interaction.



Protect Mission Critical Servers: Some hackers try to bypass controls and gain direct access to critical servers. Add PAM Server Control for host-based access files, folders, processes, registries, and connections to the Docker daemon. It can also manage who is allowed to run docker commands on a host and enable UNIX and Linux users to be authenticated using active directory and Kerberos.



Deliver Modern Applications while Controlling Cost: You have Symantec SiteMinder and Symantec IGA in place to handle customer access and lifecycle management. Your business is rapidly expanding and adding new applications. You're also fighting to manage the costs of onboarding and securing new customer accounts. By moving to an Identity Security PLA, you can support modern applications and absorb a big increase in customer business and cap your yearly costs.

Five Steps to Full Access

1. Transition your current license to an Identity Security PLA: The PLA program fee gives you access to use more of the Identity Security portfolio, and you can control usage yourself through the Digital Hub.

2. Define the Baseline for Year One: Based on multiple factors like your current run rate, your contractual entitlements, and forecasted usage, we define the program fee and baseline cost for Year One. Your total contract cost transitions to your Year One cost plus the program fee.

3. Measure Usage All Year Long: Throughout the year, we measure your usage. We prepare monthly reports and share those reports quarterly.

4. Predict Costs with Caps on Increases: The Identity Security PLA includes caps on annual increases, so your Year Two and Year Three baselines are predictable.

5. Review Usage and Adjust Baseline: At the end of year one, we reconcile your usage and that usage becomes your baseline for Year Two. At the end of Year Two, we perform the same process to adjust your usage baseline for Year 3.

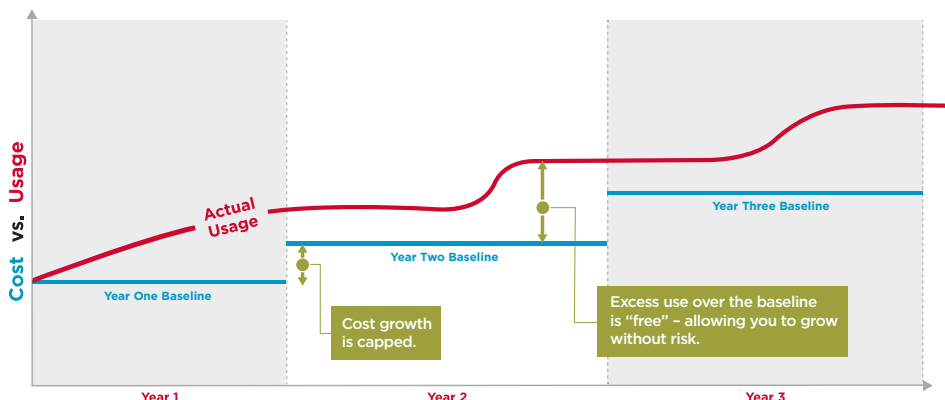

Three-Year Term Made Easy

The Symantec Identity Security PLA is a three-year term. Together, we set the baseline for year one and then automatically adjust the baseline each year thereafter based on your usage. Usage is measured by a Software Consumption Unit (SCU). For the Identity Security PLA, the SCU is the number of users.
